In Eliahu Cedars Foundation, we are committed not just in empowering our students through their academic scholarships, but we ensure that their growth will be holistic, as we want them to have a clear sense of themselves, their purpose in lives and how they can channel their gifts, talents and valuable experience to motivate, encourage and guide those future ECFI scholars to have the same motivation to succeed in their studies. Our scholars are expected to maintain a good academic record, participate and support our culture of engagement and service in ECFI, as these will also benefit them greatly.

Our pledge to uphold quality programs are unparalleled, we don't just create programs, but we strive to align ECFI's mission to the UN's Sustainable Development Goals to contribute to an inclusive and equitable quality education that will promote life-long learning opportunities for all. We believe that good education is a building block in achieving the many goals in our society that includes poverty alleviation, good health and well-being and even a better way to achieve peace and justice in our country.

Recently, the 2018 Asian Development Bank Report for the Asia Pacific Region stated that a proportion of people living on less than \$1.90 a day at 2011 purchasing power fell from 33.7% to 8.9% percent in 2013. In 2017, the rates of working poor have declined from the developing Asia and 90% percent of children now participates in organized learning. These reports have brought us great joy because ECFI's efforts in providing better access to quality education to financially challenged students aims to contribute to the bigger goals of SDG's and in the next years to come we pledge to double our effort in expanding our service to the larger community.

Program Overview

The Eliahu Cedar Foundation Inc. helps financially challenged but deserving students to gain access to tertiary education through financial aid scholarships and various mentorship support.

Future scholars can receive four to five years of scholarship funding. The primary criteria for acceptance are financial need, excellent academic records, motivation to study and willingness to fulfill his/her scholarship obligations.

After the selection period, scholarship officers assist students with their college applications through college planning, mentorship programs and sending them to a review center to increase their chance of acceptance in the country's top universities.



ECFI Finally Received its DSWD Accreditation

January 23, 2018, The Eliahu Cedars Foundation received a DSWD Certificate of Registration and License to operate after passing the government set-standard for a Social Welfare Development Agency (SWDA), the evaluation was conducted by the DSWD assessment team last January 18, 2019.

The awarding ceremony took place in the DSWD Regional Office in San Fernando, Pampanga on February 5, 2018. The event was attended by over 1,200 employees and different NGO partners. Ms. Mina Bito and Ms. Lina Velasco received the awards in behalf of the ECFI Family.





On December 13, 2018, ECFI's programs has been officially accredited by the Department of Social Welfare and Development. The certification was awarded last January 14, 2019 in Pampanga and was attended by Ms. Melissa Payongayong, ECFI's social worker.





The Importance of College Planning

Planning for your college education is important. Choosing the right course and the right university for the degree that you want to pursue matters. If you still don't know what to study at the university it is important to answer this question first and get everything right as you don't want to waste your precious time and end up quitting your studies.

You may start asking yourself about your favorite subjects or which subjects interest you. You can make a list of all the courses and search what they are all about, the subjects offered within these courses, the career options after graduation and which universities excel in these fields.

The Commission on Higher Education has an updated list of universities and colleges which are 'Center of Excellences' when it comes to specific courses, you may check their website to help you map out your options. You may also check the websites of these top universities: **The University of the Philippines, Ateneo De Manila University, University of Sto.Tomas or De La Salle University.** You can check their departments to see how they conduct their classes, class activities and other learning programs that will suit your preference.

Most of the advice that students get from their parents are to study courses which are considered practical and in-demand. Parents often focus on courses that will bring financial stability to their children and often discourage them to pursue their passion because their prospect degrees are sometimes unknown to them and they believe that it will not help their kids to land a good job. However, following one's passion is also beneficial knowing that you are going to do something you really love, and you are sure that after you graduate from college you are highly capable of performing the job you want to do.

I advice every scholar in ECFI to balance their interests and their academic strengths. If you think you will succeed in pursuing the course that you love, you should go for it. But take time to plan and not confuse yourself by just leaning towards your parents choice for you. Aside from practicality, also consider your strengths in choosing your college degree. Never be afraid to choose a university outside your hometown or degrees like Bio-chemical Engineering, Comparative Literature, or even Foreign Language Studies. If you think you have an edge in pursuing these degrees, ECFI is always here to support you and make your dreams come true.

In the Philippines, families have learned to become more resilient, poverty has been an everyday companion and instead of complaining about it they thought of creative ways to cope with it. Children join their parents in several income generating activities, they learn how to adapt during lean season and celebrate important occasions on a shoe-string budget.

Filipinos are one of the happiest people in the world, and this trait helped families to become flexible and to find ways in dealing with difficult situations. Rhea Lacupa grew up in such a family. She was one of those students who tried making ends meet during her high school years and still made it to the top. Her good academic standing, outstanding leadership skills and determination to succeed made a difference when she was finally chosen to be one of the 2018 Scholarship Awardee of ECFI.

As a scholar, she gets an assurance that her talents and abilities will be encouraged and supported. Under the ECFI Scholarship Program, she will receive a 100% financial support for her university education. She will also benefit from free tutorial services, mentoring programs and all-year round activities conducted by ECFI that is designed not only to serve ECFI scholars but also to improve the financial literacy and living condition of their families.

Marliz Verueco is a student of many achievements and academic awards, she is also the eldest among five siblings and the first in her family to reach the tertiary level. Faced with many responsibilities as an eldest daughter, she sometimes work as a part-time trimmer and marker in Aven to help augment their family income. Her parents, both factory workers have only reached grade school and high school respectively, and their income goes to support all five children. Due to this situation, they have encouraged their daughter to apply for an ECFI Scholarship Grant to help her get a college degree.

Marliz believes that earning a college diploma has a trickle down effect as it will not only benefit herself but her entire family as well. Education is the only chance to break the intergenerational transmission of poverty in their family and for them to lead a much healthier lives.

Marliz is now a freshman at the Bulacan State University in Malolos, taking up a degree in Bachelor of Technology and Livelihood Education major in Home Economics Education. This might be an ambitious dream for their family, who never had an experience of reaching the university level but they firmly believe that through their daughter's hard work and perseverance, their family will earn their first ever university diploma.



Our Story


In 2011, Mr. Mark Bechara created the Elias J. Bechara Scholarship Project to provide university scholarship grants to the academically-promising children of the less-privileged AVEN Fashion Manufacturing employees and employees of companies who work closely with Aven Fashion. The Scholarship Project was created in recognition of his father who built AVEN Fashion into one of the leading garment producers in the Philippines.

After five (5) years, Mark helped found Eliahu Cedars Foundation, Inc. (ECFI) and had it registered with the Securities and Exchange Commission (SEC). His vision was for it to flourish into one of the leading charitable organization in the Philippines. He believed that helping talented individuals gain access to quality education would be the best way to contribute to the betterment of the poverty-stricken; education, for a long time, being one of the most powerful yet peaceful weapons in the fight against hunger, poverty, illness, misery, and hopelessness.

ECFI was registered with the SEC on January 19, 2016 as a non-profit, non-government charitable organization geared towards (1) supporting the underprivileged and orphaned Filipino children in their quest for accessible, quality education, ultimately helping them become successful and responsible citizens with a sense of dignity and service, and (2) making his contribution to the bigger goal of nationwide and global development.

This 2018, ECFI received its accreditation from the Department of Social Works and Development (DSWD). The foundation continues to design and implement programs that will create social impact ensuring that the schooling of our scholars lead to learning and that our graduates contribute to the sustainable development of the greater society.
